MOTIVES FOR MURDER BASED ON NEWS IN ONLINE MEDIA KOMPAS.COM IN 2023 FROM A LEGAL SOCIOLOGY PERSPECTIVE

ABSTRAK

The number of murder crimes is decreasing from year to year which can be caused by various things. The motives for murder can be categorized into 2, namely; (1) internal motives, motives related to the biological and psychological condition of the perpetrator, and (2) external motives, economic conditions (unable to return capital, unequal distribution of wealth), conflict. The objective of the article is to reveal the motives for murders occurred during 2023. The theory of the research is sociology of law related to the factors triggering crime and the rationality driving someone to conduct murder motives. The results of the research show that based on criminal reporting published on kompas.com in 2023, 21 murder cases showed that the perpetrators of the murder were 100% men with an age range of 14-57 years, while the victims were 48% women and 52% men with a range of aged between 12-57 years. The motive for murder was caused by 57% economic motive; 33% by psychological motive and 10% by shamanic motive. The categorized data shows that the motive for the murder committed by the victim in 2023 is not much different from the previous year, that economic factors were the most dominant cause of triggering a murder. As with the course of criminal history, the most dominant cause is economic factors. The motives for murder are very complex, considering that economics as the main motive for murder means instrumental rationality as the main reason. This shows that crime is closely related to the economic conditions of society.

ABSTRAK

Penelitian Angka kejahatan pembunuhan semakin menurun dari tahun ke tahun yang dapat disebabkan oleh berbagai hal. Motif pembunuhan dapat dibedakan menjadi 2 yaitu; (1) motif internal, yaitu motif yang berkaitan dengan kondisi biologis dan psikologis pelaku, dan (2) motif eksternal, kondisi ekonomi (tidak mampu mengembalikan modal, pemerataan kekayaan), konflik. Tujuan artikel ini adalah untuk mengungkap motif pembunuhan yang terjadi pada tahun 2023. Teori yang digunakan dalam penelitian ini adalah sosiologi hukum terkait dengan faktor-faktor pemicu kejahatan dan rasionalitas yang mendorong seseorang melakukan motif pembunuhan. Hasil penelitian menunjukkan berdasarkan pelaporan kriminal dipublikasikan di kompas.com pada tahun 2023, terdapat 21 kasus pembunuhan yang menunjukkan bahwa pelaku pembunuhan tersebut 100% laki-laki dengan rentang usia 14-57 tahun, sedangkan korbannya 48% perempuan. dan 52% laki-laki dengan rentang usia antara 12-57 tahun. Motif pembunuhan disebabkan oleh 57% motif ekonomi; 33% karena motif psikologis dan 10% karena motif perdukunan. Data yang dikategorisasikan menunjukkan bahwa motif pembunuhan yang dilakukan korban pada tahun 2023 tidak jauh berbeda dengan tahun sebelumnya, bahwa faktor ekonomi menjadi penyebab paling dominan dalam memicu terjadinya pembunuhan. Sebagaimana halnya dengan perjalanan sejarah kriminalitas, penyebab yang paling dominan adalah faktor ekonomi. Motif pembunuhan sangatlah kompleks, mengingat ekonomi sebagai motif utama pembunuhan berarti rasionalitas instrumental sebagai alasan utama. Hal ini menunjukkan bahwa kejahatan sangat erat kaitannya dengan kondisi perekonomian masyarakat.

Introduction

Criminal acts have always been inherent in humans since they existed, remembering that humans have good and bad sides. This is proven by the crime column always existing in the mass media, both print and online media, both criminal and civil cases. This causes crime analysis to have significantly related to the context of events and different criminal motives so that it seeks different forms of treatment from previous types of crime.


Based on data published by BPS, it showed that the number of crime incidents in 2021 was 239,481 cases. This number has decreased from the previous year. In 2019 there were 269,324, whereas in 2020 were 247,218 with various variants of crime, including murder. Based on the seriousness of the crime, according to the Indonesian Criminal Code (KUHP) and The International Classification of Crime for Statistical Purposes (ICCS), murder (homicide) is one of the highest crimes compared to other crimes and carries severe penalties. Murder incidents occuring every year are based on the following data; In 2017 were 1,150, in 2018 were 1,024, in 2019 - 964, in 2020 were 898 and in 2021 were 927. Based on data for the last 5 years, it showed that crimes against life (murder) in Indonesia were fluctuating and tended to decrease. (bps, 2022).

The objective of the research is to determine the motives behind murder cases from a sociological perspective based on news broadcast by online media. It is expected that the results of this research can contribute to society being more careful because of the vulnerability of becoming a victim or perpetrator of murder. Policy makers are expected to be able to empower the law, to prevent criminal acts of murder and to make maximum efforts to reduce economic inequality as the main cause of murder crimes.

Literature Review

The literature review of the article is in the form of writings related to the study of criminal acts. Some literature studies relevantly to this article are: Muamalah Isnaini (2003) who wrote about Motivasi Pembunuhan dalam Novel Akui Karya Keigo Higashino. This article analyzed the motivation for murder in the novel Akui. The theory of this research was the Hierarchy of Needs Theory by Abraham Maslow. The research results showed that the motivation for the murder of the character Osamu Nonoguchi of his friend, Kunihiko Hidaka was carried out using a literary psychology approach, hierarchy of needs and intrinsic elements. Literary psychology and the hierarchy of needs were used to analyze the motive driving murder, while intrinsic elements were used to analyze character traits. The motive driving Osamu Nonoguchi's murder was an effort to fulfill the need for self-actualization, inner satisfaction and a feeling of inferiority over the other success, in this case was the character of Kunihiko Hidaka. (Isnaini, 2023).

Kosim Nur Ikhlas's (2022) article entitled *Tinjauan Kriminologi tentang Karakteristik dan Motivasi Pelaku Tindak Pidana Pembunuhan Berencana*. In criminological studies, premeditated murder is a crime against the lives of other people carried out with prior planning. This research aims to describe the characteristics of the crime of premeditated murder and determine the motive of the perpetrator of the crime of premeditated murder in decision number 118/Pid.B/2020/PN Slw. The results of the research showed that the crime of murder has elements, actions planned in advance, cumulative and interconnected, forming an inseparable series. What is meant by plan namely deciding the will in a calm atmosphere, a long enough time in the process of carrying out the will, and carrying out the will (action) in a calm atmosphere. In the context of decision number 118/Pid.B /2020/PN Slw, the crime of premeditated murder can be categorized as indirectly motivated due to economic capacity and

not being able to return capital. Meanwhile, the motivation was directly because he was hurt by the victim's sayings (Ikhlas, 2022).

Nabila (2021) with an article entitled *Motivasi Perempuan Pelaku Pembunuhan* (Studi Kasus pada Lembaga Pemasyarakatan Perempuan Kelas IIA Palembang). This research aims to determine women's motivations for committing criminal acts of murder and how they deal with their psychological conditions. There are two influencing factors, namely: (1) External factors, including economics, conflict, disharmony in family relationships, jealousy, free sex, promiscuity, nightlife, infidelity and parenting errors. This disharmony results in murder. (2) Internal factors, psychological conditions and personality, are one of the important factors that influence the subject's participation in a murder case, with the psychological condition of the subject being traumatized in the household, prolonged stress, difficulty in holding back anger, difficulty in resolving the problems faced and the personality type of someone who is vengeful, easily incited, easily carried away by emotions and unable to control anger as the cause of murder (Nabila, 2021).

Andrew P. Langelo's (2021) article entitled *Profil Pembunuhan di Kota Manado Tahun* 2018-2019. This research aims to determine the profile of murders in Manado City in 2018-2019. The type of research is retrospective descriptive with a cross-sectional design using murder case reports at the Manado's City Police in 2018-2019. The results of the research found that there were 17 murder cases in 2018-2019 in Manado City, with the most frequent violence being sharpened at 15 cases (88%). Most perpetrators were male (94%) and aged 17-25 years (59%). Most victims were male (100%) and aged 17-25 years (53%). Of the 17 cases, 13 cases were autopsied (76%). The conclusion of this research was that the murder rate in Manado City tended to decrease, but the death rate due to sharp violence was still quite high and the majority of victims and perpetrators are male students (Langelo et al., 2021).

Umi Enggarsasi's writing (2013) titled *Gangguan Jiwa sebagai Salah Satu Faktor Penyebab Terjadinya Pembunuhan*. Murder is caused by various factors, which cause the perpetrator to receive punishment. One of the factors causing murder is mental disorder, causing the perpetrator not to be punished because his psychological condition makes it impossible for him to be punished because he is unable to take responsibility. In dealing with people with mental disorders who have committed murder, other experts need to provide information to achieve maximum results and to avoid the emergence of simulations that can cause victims. In fact, in Indonesia, until this recent, people with mental disorders who commit criminal acts are regulated in Article 44 of the Criminal Code (KUHP). Compared with the types of mental disorders in the Guidelines for the Classification and Diagnosis of Mental Disorders in Indonesia, 2nd edition in 1983, the existing regulations cannot cover them and it is very necessary to have psychiatrists and psychologists to carry out observations and provide information regarding ability to take responsibility. And to achieve good cooperation between the judiciary and other experts in treating defendants, each party must know the existing procedures, so that the parties concerned do not feel disadvantaged (Enggarsasi, 2013).

Diah Erna Wilis (1999) wrote Santet sebagai Salah Satu Faktor Penyebab Pembunuhan Masal (Suatu Studi Yuridis Kriminologis berdasarkan Data di Kabupaten Banyuwangi). Murders caused by black magic are very scary and threaten people's lives. The most difficult thing is to prove the perpetrator of black magic, which often leads to vigilantism against perpetrators of black magic. The research results show that the motivation for murder is due to personal revenge, taking advantage of the situation for its own sake and making political decisions (Wilis, 1999).

Writing by Adinda Ramadani Tess (2021), *Tinjauan Kriminologi Tindak Pidana Pembunuhan*. The research results showed that the factors causing the crime of murder were psychological, misunderstanding, hurt, low faith and romance factors (Tess, 2021). Meanwhile, Moh Ismail (2013) wrote *Tinjauan Kriminologis Dalam Pembunuhan Berencana Di Kota Palu*.

This research examined the factors triggering the crime of premeditated murder and what kind of efforts have to prevent and overcome the crime of premeditated murder in Palu. The research results showed that the factors triggering premeditated murder are caused by indirect factors, including economy, social environment and technological developments, and direct factors including the factor of revenge and the influence of alcohol (drunk). Efforts to deal with murder are preventive and repressive (Ismail, 2013).

Octaviani Sefti (2015) conducted Analisis Kriminologis Kejahatan Pembunuhan Berencana yang Dilakukan oleh Pelaku Terhadap Mantan Kekasih. This research discussed the factors leading to and efforts to overcome the crime of premeditated murder committed by the perpetrator against his ex-lover. The results of the study concluded that several factors led to murder were internal factors, including age, emotional power, education, psychological and external factors including religion, what have been watched and read factors. Efforts to overcome the crime of premeditated murder were conducted using non-penal and penal means in a preventive and repressive manner (Sefti, 2015).


Khairul Ihsan (2016) wrote factors causing Faktor Penyebab Anak melakukan Tindakan Kriminal (Studi Kasus Lembaga Pemasyarakatan Pekanbaru Kelas II B). There were many factors triggering someone to commit criminal acts, including cultural conflict and competition, differences in political ideology, population density and composition, differences in cultural distribution, inequality in wealth and income, unstable mentalities, and other basic factors such as biological, psychological and socio-emotional factors. Criminal acts were one of the negative impacts caused by development. Factors causing criminal acts by children wetreconomic factors, education, environment, weak law enforcement and negligence of parents in educating children (Ihsan and Jonyanis, 2016).

Theoretical Framework

The theory of sociology of law is to analyze crime problems, in this case the criminal act of murder which the definition of criminology is the study of crime or criminals. Criminology comes from the words *crimen*, which means crime or criminal, and *logos*, which means science. Criminology is also defined as the study of human behavior that deviates from its habits, multidisciplinary and the study of crime as a social phenomenon. (Soerjono, 2001). The definition of murder is based on the Criminal Code, Book 2, chapter IX, article 338, murder, that is whoever deliberately takes the life of another person, is threatened with a maximum prison sentence of 15 years for murder (Handoko, 2018).

Factors causing criminal acts can be classified into:

- 1. Physical Aspects (Criminal Biology)
 The character is Cesare Lombroso, who has a special type of shape or certain defects, a factor of destiny as a criminal, a personality due to atavism that cannot be avoided.
- 2. Psychological and Psychiatric Aspects (Criminal Psychology)
 Psychologically, a criminal is someone who has a different mental condition from others.
 The psychological characteristics of criminals include psychoses (organic psychoses, functional psychoses), neurosis and a mental defect called psychopathy characterized by an inability to learn from experience, a lack of guilt and a lack of warmth; a criminal has a mental disorder character, having an excessive sense of wrongdoing, which trigger him/her to commit a crime, thus, he/she can receive appropriate punishment. Criminals have an abnormal mindset so they decide to commit crimes due to their anger, and have inflated self-esteem so they commit crimes. According to a psychological perspective, crime is a representation of psychological conflict.
- 3. Economic, Sociological and Cultural Aspects





In its historical development, crime was caused by economic factors, including the desire to enjoy luxury and conditions of deprivation or poverty, thus, it could be said that economic factors were the main factor causing criminal behavior.

Social factors that cause crime are:

- 1. Strains (various forms of tension in society) triggering someone to commit criminal acts
- 2. Cultural Deviance which states that crimes occur based on social class, especially those from the lower class. Poor people have a geographical environment that trigger them to commit crimes
- 3. Low social control in society

Loose regulations in society are one of the triggers for crime.

According to Weber in his theory of rational action, there are several acts of rationality that cause criminal acts to be committed by someone:

- 1. Traditional form (with characteristics: irrational formal legal system and rational substantive)
- 2. Form of charismatic authority (with characteristics: formal, irrational, substantive irrational)
- 3. Rational form of law (with characteristics: formal, rational and logical) (Muryanti, 2020).

Research Methods

The research method of the research is descriptive qualitative research. Qualitative research is a type of research using descriptive data in the form of someone's spoken or written language to explain a certain phenomena. The spoken or written language originates from narratives, stories, expressions or constructions from informants. Qualitative research aims to present basic information about the research subject and can describe in detail the object being studied (Muhajir, 1990). This is what causes the role of a researcher to be important in interpreting data obtained in the field (Moleong, 1999).

Data collecting was carried out by collecting secondary data through criminal data published in online media, namely kompas.com in 2023. The online media kompas.com was chosen because it is one of the most trusted media in presenting data in Indonesia, including crime cases. The year 2023 was chosen because there are a large number of cases presented, the cases are still fresh in the minds of writers and readers because they are widely broadcasted in online media, not only by kompas.com.

Based on the crime cases obtained from the exploring process from kompas.com, the types of cases were then classified. Categorization of cases is important considering that criminal cases are numerous and varied. Murder is just one of the criminal cases whose number has increased year by year over the last five years. Then the murder cases are classified again based on the motives for the murder, whether the murder was caused by internal or external factors. Therefore, a series of data on murder cases occurred in 2023 can be narrated using various motives for murder, economic factors being the highest, followed by psychological factors.

The data analysis process was carried out from the beginning of the data collection process, namely extracting secondary data through kompas.com, case categorization to the process of drawing conclusions about the motivation for the murder committed by the criminal. Data reduction was carried out by reducing criminal cases appeared in 2023 not only murder cases. Reduction was also carried out with the chronology of the case, a series of stories to be drawn into the motive for the murder. The data was presented in tabular form, in order to make categorization process easier, neater and more organized. The analysis was carried out by examining previous writings about murder to find out the motives that often appear, then adding Weber's theory of rationality to further explain the typology of murder.

Results And Discussion

The crime of murder is an action always existing in human history. This incident does not recognize gender, age and background. Anyone can do such actions in different contexts. In the early history, Aristotle stated that humans' desire to live in luxury was the main trigger for murder, economic shortages and the need for existence.

Previous research on murder explained that the factors causing the crime of murder can be categorized into:

- 1. Internal factors, which are related to the biological and psychological condition of the perpetrator (prolonged stress, revenge, easily provoked, carried away by emotions and unable to control anger, hurt by the victim's sayings, self-actualization, inner satisfaction, low self-esteem, mental disorders, personal grudges, psychological facts, hurt by misunderstandings, low faith and romance, age, emotional, education (Isnaini, 2023) (Nabila, 2021) (Ikhlas, 2022) (Enggarsasi, 2013) (Wilis, 1999) (Sefti, 2015) (Ihsan and Jonyanis, 2016)
- 2. External factors, which are related to economic conditions (unable to return capital, unequal distribution of wealth), conflict, family disharmony, jealousy, free sex, promiscuity, nightlife, infidelity, bad parenting, taking advantage of circumstances for its own sake and make decisions politics, environment, technology, religion, spectacle, reading, culture, ideology, population density, unequal distribution of culture, negligence and children education, education (Ikhlas, 2022) (Nabila, 2021) (Wilis, 1999) (Sefti, 2015) (Ihsan and Jonyanis, 2016)

Based on data obtained by kompas.com, several acts of murder occurred during 2023 are as follows:




The data presented in the table shows that the perpetrators of the murder were 100% male with an age range of 14-57 years, while the victims were 48% female and 52% male with an age range of 12-57 years. Regarding motives for murder, in the current development of society, the motives for committing crimes of murder are not much different from before. The most common motives for murder are external factors (economics, shamanism and politics) and internal factors, psychological conditions and romance. There were 21 criminal cases of murder published on kompas.com, which can be detailed as follows:

- 1. The cause of murder was economic factors, as many as 12 cases (57%)
- 2. The cause of murder was being offended, 3 cases (14%)
- 3. The cause of murder was romance, 4 cases (19%)
- 4. Cause of murder was other factors (politics and shamanism), 2 cases (10%)

Economic factor is the main cause of murder, with variations in the context of the incident, including applying for debt and being rejected, being in debt, job, stealing money, gambling and the desire for luxury.

According to Weber's view, the motives of perpetrators who commit murder are not only caused by a single causal factor, but also by several factors that cause and influence each other. Based on the narrative about the murder of the perpetrator, economic, political and psychological actions fall more into the category of rationality motives, while actions to gain supernatural powers as a sacrifice for committing murder can be categorized as charismatic







motives. Economic causes as the cause of criminal acts are the preminant reason, therefore, instrumental rationality is the main motive causing individuals to commit murder crimes.

Conclusion

Based on criminal reports published on kompas.com in 2023, there were 21 murder cases showing that the perpetrators of the murder were 100% male with an age range of 14-57 years, while the victims were 48% female and 52% male with an age range of 12-57 years. 57 years old. The motive for murder was caused by 57% economic motives; 33% were caused by psychological motives and 10% were caused by shamanic motives. The categorized data shows that the motive for the murder committed by the victim in 2023 is not much different from the previous year, that economic factors were the most dominant cause of the murder. According to Weber's view, the motive for murder is very complex, the main cause is an act of instrumental and charismatic rationality. This shows that crime is closely related to the economic conditions of society.


The data obtained in this research is secondary data, thus, the facts collected are based on information published by online media. The author did not conduct direct observations and interviews with victims and perpetrators of criminal acts of murder, thus, triangulation was carried out by looking for secondary data published in other online media on the same case. The results of this research complement previous research on murder motives and are expected to contribute to legal sociology research.
